



Attention is invited to note no. 7 to the statement that the consolidated unaudited financial results include the interim financial statements/ financial information/ financial results of one associate which have not been reviewed/audited by their auditors, whose interim financial statements/ financial information/ financial results reflect Group's share of net profit after tax of Rs. 117.29 lakhs and other comprehensive income of Nil for the quarter ended 30th June 2021, as considered in the consolidated unaudited financial results. Accordingly, Group's share of net profit in associate of Rs. 117.29 lakhs included in consolidated financial results, constituting 24.77% of consolidated net profit, is based on unaudited/unreviewed statement of that associate.
